City of Martensdale Regular City Council Meeting Minutes April 7, 2025

Mayor ProTem Hutchison called the meeting to order.

The pledge of allegiance.

Members present: Scott Henson, Travis Berger, Matt Gideon and Peggy Halterman.

Members absent: Mayor Prichard absent.

The agenda was approved by Henson and seconded by Berger. On a roll call vote: Henson, Aye; Gideon, Aye; Hutchison, Aye; and Halterman, Aye. Mayor ProTem Hutchison declared the motion carried unanimously.

Citizens Comments: None.

The consent agenda was presented: the March 11, 2025 minutes, the March 2025 payables and receipts, April 2025 payables and the February 2025 financials. Gideon made a motion to approve the consent agenda; seconded by Halterman. On a roll call vote: Henson, Aye; Berger, Aye; Gideon, Aye; and Halterman, Aye. Mayor ProTem Hutchison declared the motion carried unanimously.

Chad Daniels was present to get approval for a 2-mile radius for property owned by Russ Sandquist, Location: Part of Parcel P of the SE 14 of the SW 1/4 of Section 27 and the NE14 of the NW14 of Section 34, T 76N, R25W, Warren County, Iowa. The property will be split into two sections for 2 single family homes. Gideon made a motion to approve the 2-mile radius for Russ Sandquist property; seconded by Henson. On a roll call vote: Henson, Aye; Berger, Aye; Gideon, Aye; and Halterman, Aye. Mayor ProTem Hutchison declared the motion carried unanimously.

Anthony Gulbrandsen from Vantage Point Solutions, Mitchell, SD was present to get approved to run fiber optic lines down by the DOT station, a small section of Martensdale, IA will be included in the area of the new fiber optic line. Henson made a motion to approve Vantage Point Solutions to install the fiber optic lines; seconded by Gideon. On a roll call vote: Henson, Aye; Berger, Aye; Gideon, Aye; and Halterman, Aye. Mayor ProTem Hutchison declared the motion carried unanimously.

The city council asked Mr. Gulbrandsen if the City of Martensdale would be included with fiber optic lines in the future, Mr. Gulbrandsen stated he believed it would not be long before Martensdale would be offered the fiber optic lines.

Zach Wood stated the roof color samples will be dropped off this week. He asked if the city attorney had replied to the culverts in town, the city clerk will contact the city attorney and get his opinion.

Chief Scott Henson stated there were 19 EMS calls and 23 fire calls in March 2025.

The 2025-2026 budget was presented, Henson made a motion to approve the budget and set the public hearing date for April 28, 2025 at 6:00 p.m.; seconded by Berger.
